Domestic Toll:

(a) Minimum quarterly toll of \$64.10 for the first 62 cubic meters (13,640 imperial gallons) or any part thereof.

(b) All water used in excess of 62 cubic meters (13,640 gallons) per billing shall be charged for at the rate of \$1.05per cubic meter (220 gallons) or any part thereof.

Commercial Toll:

(a) Minimum quarterly toll of \$89.25 for the first 62 cubic meters (13,640 imperial gallons) or part thereof.

(b) All water used in excess of 62 cubic meters (13,640 gallons) per billing shall be charged for at the rate of \$1.05 per cubic meter (220 gallons) or any part thereof.

Property Tax Exempt Domestic Toll:

(a) Minimum quarterly toll of \$155.34 for the first 62 cubic meters (13,640 imperial gallons) or any part thereof.

(b) All water used in excess of 62 cubic meters (13,640 gallons) per billing shall be charged for at the rate of \$1.05 per cubic meter (220 gallons) or any part thereof.

Property Tax Exempt Commercial Toll:

- (a) Minimum quarterly toll of \$221.73 for the first 62 cubic meters (13,640 imperial gallons) or part thereof.
- (b) All water used in excess of 62 cubic meters (13,640 gallons) per billing shall be charged for at the rate of \$1.05 per cubic meter (220 gallons) or any part thereof.
